These gems are, in turn expertly sorted, polished and cut by master artisans. Each piece is individually crafted by hand according to the highest standards, in 18K Gold, Platinum or Sterling Silver.

One-Year Warranty

All Laurence Bruyninckx jewelry is guaranteed to be free from defects in craftsmanship and materials for one year. We make jewelry the way it should be made, crafted with care to last a lifetime. And actually, if you treat it well, your Laurence Bruyninckx jewel will last much longer than a lifetime, even when worn and enjoyed every day.

That doesn't mean fine jewelry is indestructible! Your warranty doesn't cover being run over by a car, being washed in the washing machine, extreme sports and other things that aren't normal wear, so exercise some caution and restraint. Having another jeweler re-size or work on your piece also voids your warranty.

To keep your fine jewelry beautiful for the next generation, we recommend regular professional cleaning and maintenance. Prongs may need to be tightened every year or two to keep gems secure so make sure to have them checked when your piece is cleaned. RETURN & REFUND POLICY

We hope you are 100% satisfied with your purchase of Laurence Bruyninckx jewelry. We manufacture many of our jewelry pieces in New York. When we manufacture jewelry overseas, we work only with companies that are members of the Responsible Jewelry Council. Our diamonds are supplied by DTC Sightholders, and cut in factories that are certified through the De Beers Best Practice Principles assurance program of ethical, social, employment, health, and safety standards which is confirmed regularly by third-party auditors.

Most one-size items are in stock and ready to ship. PRODUCT CARE AND MAINTENANCE

Sterling Silver Jewelry

Give sterling silver jewelry a little polishing from time to time with a soft cotton cloth and a good commercial silver polish to keep it gleaming. Keeping your sterling silver items away from tarnishing elements such as paper, cloth, and rubber bands help to keep it in good condition.

18K Gold Jewelry

Store jewels with gemstones in a soft pouch separate from other jewelry. Avoid contact with perfumes, cosmetics, hairspray, and household cleaners. Avoid contact with chlorinated pool water, sea salt water, and extreme activities such as contact sports, gardening, rock climbing etc. Clean your gemstone jewelry

with a professional jewelry cleaner, or with a solution of warm water and ammonia, rinsing thoroughly and polishing carefully with a dry cloth to remove any residue.

Over time, fine jewelry can become a treasured family heirloom if it is cared for properly. Dust, pollution and daily wear all conspire to cloud the brilliance of gemstones. The surface of gold, platinum and silver jewelry can become dulled. Timeworn prongs and clasps can result in the loss of a stone or an entire piece of jewelry. For these reasons, professional cleanings are recommended as often as once a year. Laurence Bruyninckx You must contact contact info@lx-antwerp.com for any repair or maintenance as the use of a non-authorized jeweler may void the terms of your warranty.

Rhodium Jewelry

About Rhodium-finished Jewelry: To clean and maintain the fabulous look of your rhodium plated jewelry, don't use any chemicals on it. Not even toothpaste. Do not use a toothbrush (if it is a used brush, it may have residues of toothpaste; if it's new, it may scratch the rhodium plate). Please only use soft cloths specially produced to work with silver or gold jewelry. Don't even think about an ultrasonic cleaner and don't use any abrasive of any type. Forget about silver dips. Don't even try products made from ammonia. You can wash any makeup ONLY with water or few drops of shampoo that is warm and then rub it off.

Here are some common issues that you may encounter:

With a rhodium-finished ring that you wear a lot, the rhodium plate will start to wear off because of the constant friction. The wear generally begins at the shank (the part of the ring that touches your skin). This will also happen with earrings, pendants and bangles, but to a lesser degree. If you have a rhodium-finished piece of jewelry, you'll notice the wearing when the metal starts to turn yellow or looks dull. This is normal and the finish can be reapplied by a professional jeweler.
